## **Introductory Course on Climate Rights Litigation**









### **Course Syllabus**

# **Learning Objectives**

Litigants assert a broad range of legal theories, some of which are premised on climate-related legal obligations and others which seek to effect greater climate action through laws and policies not specifically enacted to address climate change. This course focuses on cases arguing that insufficient action to mitigate or adapt to climate change violates plaintiffs' international or constitutional rights to a healthy environment, life, health, food, water, liberty, family life, and more. The same rights support claims that governments' failures to adapt to the impacts of climate change breach these obligations. Recent years have seen an increased number of these "climate rights" cases.

This course explores the role of litigation premised on human rights in addressing climate change. After introducing several of the most commonly cited sources of climate rights, the course addresses the reasons that people around the world look to courts as a way of tackling climate change. The course then looks in greater depth at cases filed in several key contexts. Those include cases in national courts that deal with national mitigation and adaptation commitments, cases challenging particular policies or projects, cases in international fora, and cases brought by and on behalf of persons in vulnerable situations.

# Content & Duration

This online course is composed of 6 lessons which are organized in interactive modules and combine the course theory with exercises and interactions to facilitate the learning process. The core content of the lessons is complemented with numerous references to primary sources and additional resources on external websites.

It will take you approximately 2 hours to complete the full course, excluding additional materials. This is a self-paced course that allows you to manage your time as you wish. You can navigate the lessons at your convenience and retake them whenever you wish.

Studying cases challenging the climate impacts of specific projects or policies pursued or authorized by national governments.

#### Lesson 5: Cases in International Fora

Presenting significant cases in international settings and describing the role they can play in climate governance.

## Lesson 6: Cases Addressing the Rights of Persons, Groups, and Peoples in Vulnerable Situations

Identifying significant cases brought by children and youth, Indigenous Peoples, and other groups situated differently from the public at large.
